### WORKERS COMPENSATION

- By the applicable state law, TechAnax pays 100% of the premium.

### RETIREMENT PLAN

- 401(k) Qualified Retirement Plan – TechAnax offers both a traditional tax-deferred 401(k) plan in which you may contribute to your 401(k) plan with pre-tax dollars and a Roth 401(k) option in which you may contribute to your 401(k) plan with after-tax dollars. TechAnax can either match your contribution or elect to contribute to the Profit-Sharing Plan for the Plan Year.).
- You are eligible to participate in the salary deferral part of the 401(k) plan on the 1st day of the month on or following your date of hire. To be eligible for the company matching contribution, you must participate in the 401(k) plan at any time during the Plan Year (the period January 1- December 31) and be employed on the last day of the Plan Year.
- Company matching contributions vest annually.

### LIFE, ACCIDENTAL DEATH AND DISMEMBERMENT, AND SHORT AND LONG-TERM DISABILITY INSURANCE

- TechAnax covers 100% of the \$50,000 life and accidental death and dismemberment insurance policies through UNUM.
- Short-term and long-term disability insurance is paid 100% by TechAnax for the employee's benefit.

### TRAINING AND EDUCATION PROGRAMS

- **Certification Reimbursement.** Certification reimbursement is available for employees who wish to maintain their technical relevancy and improve their knowledge, skills, and abilities by continuing education toward accredited certifications. The maximum reimbursement is \$2,000 per calendar year, with a service commitment of \$200 per calendar month worked until the total reimbursement amount is repaid.

**\*Floating Holidays:** Subject to customer requirements & PM approval, you may substitute your birthday, Inauguration Day, the day after Thanksgiving, the day before Christmas, and/or the day after Christmas for one or more of three floating holidays, provided you do not exceed 10 holidays in the calendar year.

### PERSONAL LEAVE PLAN

- Personal Leave enables you to accrue days off in a single account and use them according to your personal needs. Your leave hours are accrued proportionally on a pay-period-by-pay-period basis.
  - Employed less than 3 years: 120 hours of personal leave.
  - Employed more than 3 years: 160 hours of personal leave.

### MISCELLANEOUS LEAVE

- **Bereavement Leave.** Up to three days per bereavement event per year.
- **Jury Duty.** The difference between your salary and jury fee for up to 10 days.
- **Military Leave.** Leave without pay, continued benefits.
